---

Trial Grounds Hours: 7:00 am – 1/2 hour after last run.

Please note – this trial site is private property! Please keep your dogs and/or children away from the residence and its fenced yard. Do not “potty” your dogs near the fence around the house.

Please be courteous and pick up after your dog.

All dogs MUST be on leash at all times, except when competing.

It is expressly understood that exhibitors, alone, are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund on any fees paid will be made.

Please do not throw garbage in Port-a-Potties.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian, Judge, or Tester or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances or other acts beyond the control of the club, it is impossible to open or complete the show, no refund or entry fee will be made.

Dogs must be ready for their classes. Test/Trial judges have the authority to refuse to judge any dog that does not appear within five minutes of being called for its run.
